Thonburi Healthcare Group Public Company Limited ("THG") would like to inform the resolutions of the Board of Directors' Meeting No. 2/2022, held on 15 February 2022, with the following significant resolutions:

To certify the financial statements for the year ended 31 December 2021
 Board's Opinion certified the financial statements for the year ended 31 December 2021, as audited and certified by the auditor. The matter should be proposed to the Annual General Meeting of Shareholders for further consideration and approval.

2. To agree the appropriation of net profit as legal reserve and the dividend payment for 2021

<u>Board's Opinion</u> THG had appropriated the legal reserve for Baht 112.5 million, representing 13% of paid-up capital, therefore it is not necessary to further allocate profits to the legal reserve for this period.

THG's net profit from the separate financial statements was approximately of Baht 930.83 million, therefore, it was deemed appropriate to pay dividends for the operating results of the year 2021 to shareholders at the rate of Baht 0.90 per share, equivalent to 81.8% of the total net profit, totaling Baht 762.72 million. The dividend payment rate is in accordance with THG's dividend policy.

- A. To propose the shareholder's meeting to acknowledge the interim dividend payment for the business performance from 1 January 2021 to 30 September 2021 at the rate of 0.40 baht per share, totaling dividends of Baht 338.99 million, which will be paid on 25 February 2022. This interim dividend had been paid from the corporate income tax rate of 20%.
- B. To propose the shareholder's meeting to pay the remaining dividends at the rate of 0.50 baht per share, totaling dividend payment is of Baht 423.73 million. The



date for the right of shareholders to receive dividends will be on 23 March 2022, with the payment of dividends by 27 May 2022. This dividend will be paid from the corporate income tax rate of 20%. The right to receive dividend is uncertain as it has not yet been approved by shareholders."

- 3. To agree the appointment of auditors and the auditors' fee for the fiscal year ended 31 December 2022
  - <u>Board's Opinion</u> agreed the appointment of auditors from PricewaterhouseCoopers ABAS Ltd. to be the auditors of THG and its subsidiaries for the fiscal year ended 31 December 2022. The audit fees of the consolidated financial statements, Separate financial statements of THG and 6 subsidiaries, including quarterly review fees are not more than 8,350,000 baht and the audit fees for 5 subsidiaries are not more than 170,000 baht. The matter should be proposed to the Annual General Meeting of Shareholders for consideration and approval.
- 4. To consider approving the appointment of new directors to replace those retiring by rotation Board's Opinion agreed the appointment of new directors to replace 1 in 3 of the directors retired by rotation. In 2022, THG had 13 directors by rotation the following 4 directors are retired:
